INNOVATION PROJECT THAT CONCERNS ALL MEMBER STATES OF THE EUROPEAN UNION

The principal aim of the two years project, ending in the end of 2009, but susceptible to continue in the private sector, is to develop an educational program for community healthcare specialists, based on e-learning modules diffused remotely with the use of ITC, in order to provide nurses and midwives with the most efficient training. Furthermore, other healthcare specialisations could eventually adopt this methodology.

E-learning educational modules for community health professionals are being elaborated by the best Czech, Polish and Slovakian educators and will afterward be remotely tested by nurses and midwives of these countries and also by their French colleagues. The association FORMATIC SANTE, a network for exchange and online education for healthcare professionals, will be in charge of the call for volunteers, organization of the tests and the inscription of all the professionals willing to participate and to benefit from the e-learning modules free of charge (www.formaticsante.com). The test phase will take place in the end of 2008 – February 2009. Each course will be available in the national language pf each participating country and in English, and may eventually be translated in other European languages, should any other member state, like France, be interested.

UNIVERSAL DIMENSION

Since the WHO Declaration of Alma Ata of 1978, there are more and more healthcare communities (e.g., public healthcare services, school healthcare systems, home healthcare, healthcare for workers, etc.) where nurses occupy a very important place, as they act within all the communities in question at the local, national and European levels. Nevertheless, there are but very few specialized training courses for nurses available and even fewer of those available remotely, while communities in need of adapted healthcare services do not cease to grow and become more and more diversified. The first of them, Family, may thus be traditional, reconstituted, single-parent, relating to gay parenting, having babies, teenagers, young adults, etc.
